The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 05.05.2025 & 06.05.2025, followed by hearing on 13.06.2025. The Medical Assessment and Rating Board has examined the inspection report of college as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020.
2. Considering the inspection report & hearing MARBH has decided to issue Permission to R. N. Kapoor Homoeopathic Medical College, Indore- Dewas Bypass Road, A P J Abdul Kalum Vill- Arandia, Indore- 452016 for conducting BHMS course with intake capacity of 100 seats for academic year 2025-26.
3. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate (BHMS) seats permitted shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats shall be conducted by the concerned counseling authority of the state/UT.
4. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students and without permission of counseling board will not be approved by the Medical Assessment and Rating Board.



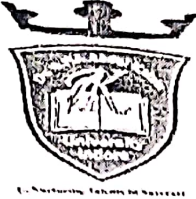
